Trip Cancellation & Interruption

Trip Delay

Provides reimbursement of additional costs for accommodations, transportation and meals if a trip is delayed for a covered reason*. (Not available for NY)

Baggage & Personal Effects

Provides reimbursement for lost and stolen personal items.

Baggage Delay - Sports Equipment Rental

Provides reimbursement for the cost of renting sports equipment if your checked sports equipment is lost or delayed by a common carrier for more than 12 hours.

Emergency Accident & Sickness Medical Expense

Provides reimbursement for emergency medical treatment if sickness or injury occurs while traveling.

Emergency Medical Evacuation

Provides coverage for emergency medical evacuation, if necessary, to the nearest adequate medical facility, or back to the USA, also includes return of remains.

14 Day Free Look Period
