Trip Cancellation & Interruption - What's Covered?

Here are a few examples of covered trip cancellation and interruption perils. - Sickness, injury, or death of insured, a family member, or a travel companion
- Insured's primary residence or destination being rendered uninhabitable by fire, flood, other natural disaster, vandalism, or burglary
- Documented theft of passports/visas
- Involved in a merger, job loss, or job relocation
- Documented traffic accident
- Unannounced strike
- Inclement weather that causes cessation of services provided by your common carrier
- Mechanical breakdown of the common carrier
- Evacuations due to natural disasters
